New Appointments Complement Recent Additions to Senior Management Team

The appointment of Messrs. Gosselin, Holt and Forsyth will augment the Company's recent addition of Paul Miller as Chief Operating Officer and George Parise as Chief Financial Officer to comprise a leadership team that will focus on building an integrated, go-to-market strategy for continued growth in the M2M, AVL, POS and email and messaging business segments.

As Chief Operating Officer, Mr. Miller has responsibility for leading the day-to-day operations and planning of Velocita Wireless. The Company's customer operations, networking and information technologies groups report directly to Mr. Miller.
